Privacy Policy

1. INTRODUCTION

Inka's Resorts S.A.C, hereinafter "AMOTAPE", guarantees the maximum reserve and protection of the personal data that Users enter in the different digital platforms that are under its administration and ownership, hereinafter the "websites".

This document describes the "Privacy Policy" that regulates the treatment of personal data that Users provide on the websites of Amotape, in accordance with the indicated regulations.

2. OBJECTIVE AND PURPOSE

In AMOTAPE we are aware of the high consideration that has the privacy of our users and all those who are interested in our products and services. Therefore, we are committed to respect your privacy and protect the confidentiality of your private information and personal data. For that reason, the purpose of this Privacy Policy is to inform our Users about the way in which personal data are collected, treated and protected, in accordance with Law No. 29733 "Personal Data Protection Law", which are entered in the websites AMOTAPE makes available.

3. LEGISLATION

- Legislative Decree N° 1353, Legislative Decree that creates the National Authority of Transparency and Access to Public Information, strengthens the personal data protection regime and the regulation of interest management.

- Information Security Directive, approved by Directorial Resolution N° 019-2013-JUS/DGPDP.

AMOTAPE develops its Privacy Policy by which it establishes the guidelines for the treatment of personal data in accordance with the guiding principles set forth in Law No. 29733 - Personal Data Protection Law as follows:

Principle of Legality

Refuses the collection of our Users' personal data by fraudulent, unfair or unlawful means.

Principle of Consent

In the processing of our Users' personal data, their free, prior, express, informed and unequivocal consent is required.

Principle of Legality

The personal data of our Users will be collected for the determined, explicit and lawful purpose detailed in this Privacy Policy and will not be extended to any purpose other than the one unequivocally established as such at the time of collection.

Proportionality Principle

The personal data to be processed shall be truthful, accurate, updated as far as possible, necessary, relevant and adequate with respect to the purpose for which they were collected. They shall be kept in a form that ensures their security and only for the time required to fulfill the purpose of the processing.

Security Principle

AMOTAPE and, where appropriate, the data processors, adopt the necessary technical, organizational and legal measures to ensure the security and confidentiality of personal data.

Principle of Availability of Resources

AMOTAPE informs its Users that they may exercise their right to the protection of personal data contained in article 2, paragraph 6) of the 1993 Constitution, before the National Data Protection Authority and in a jurisdictional venue before the Judicial Power for the purpose of initiating the corresponding habeas data process.
